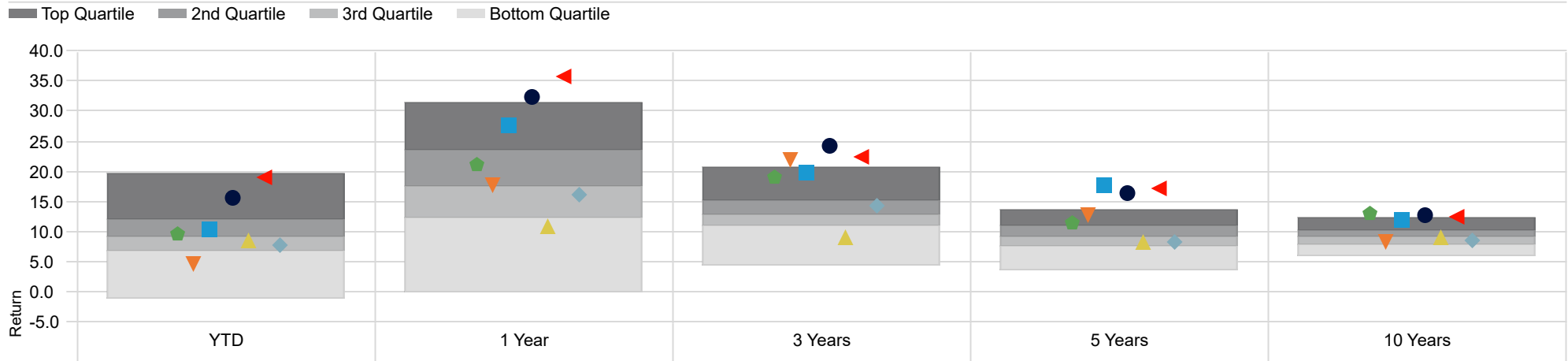

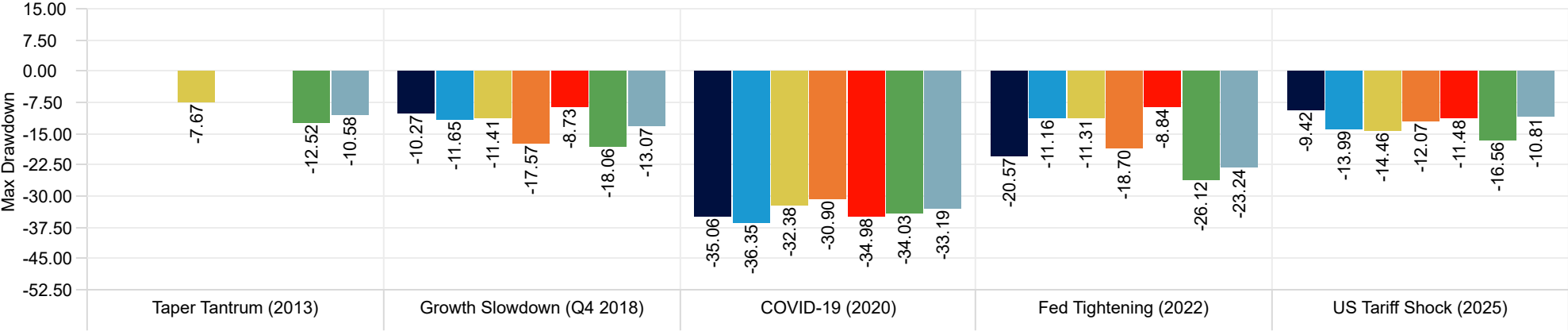

Market Dislocation Max DrawDown

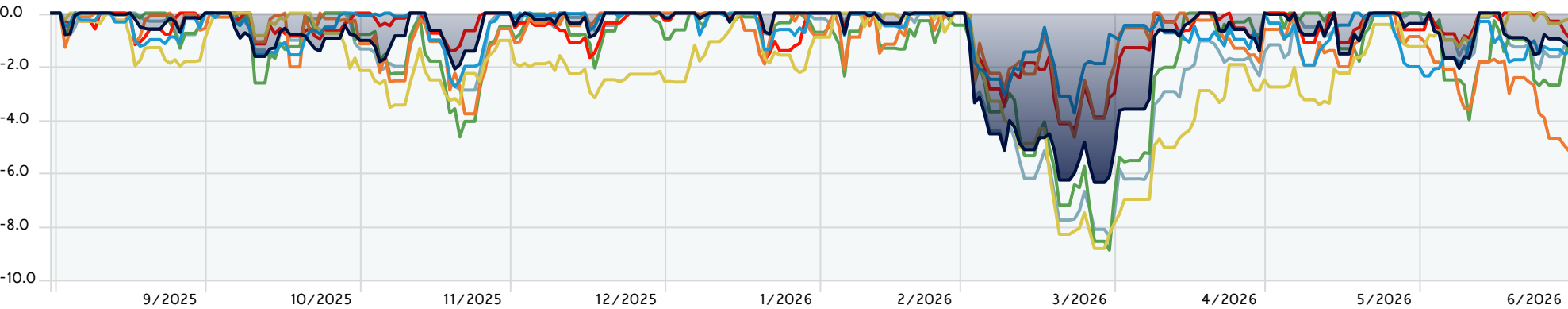

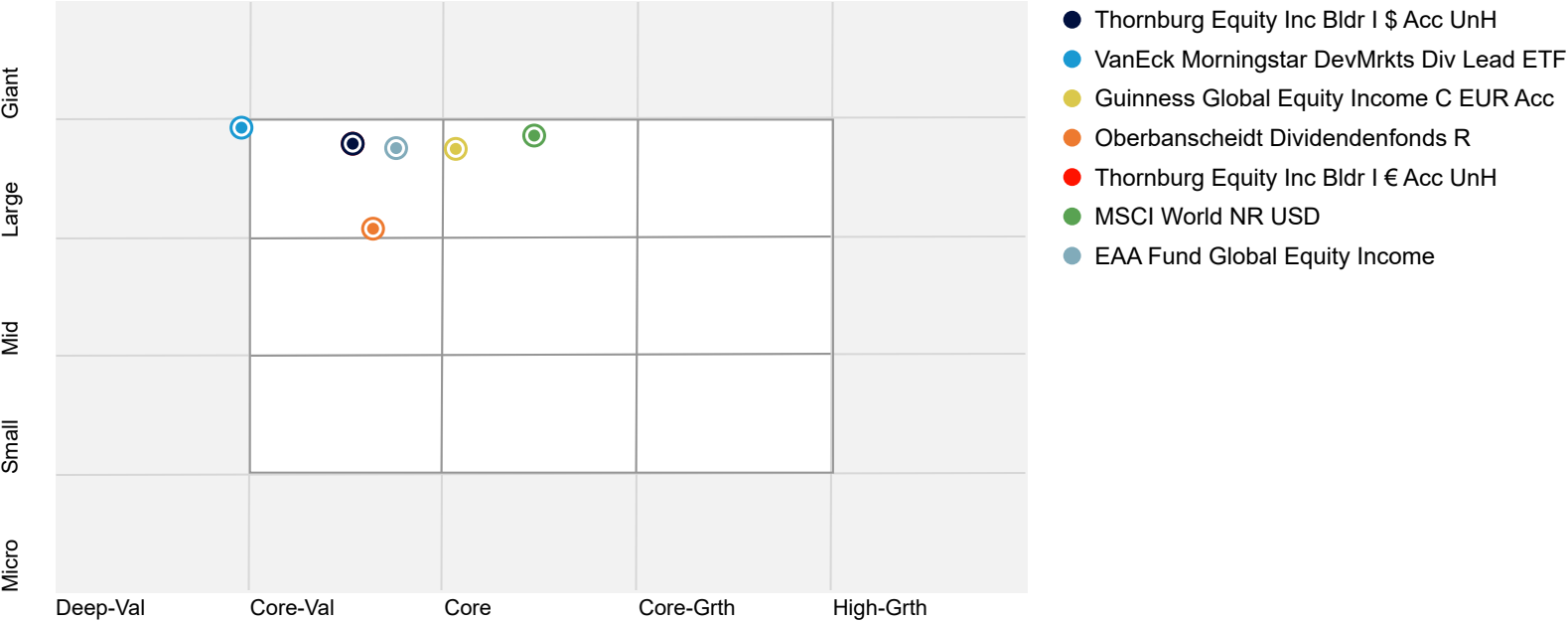

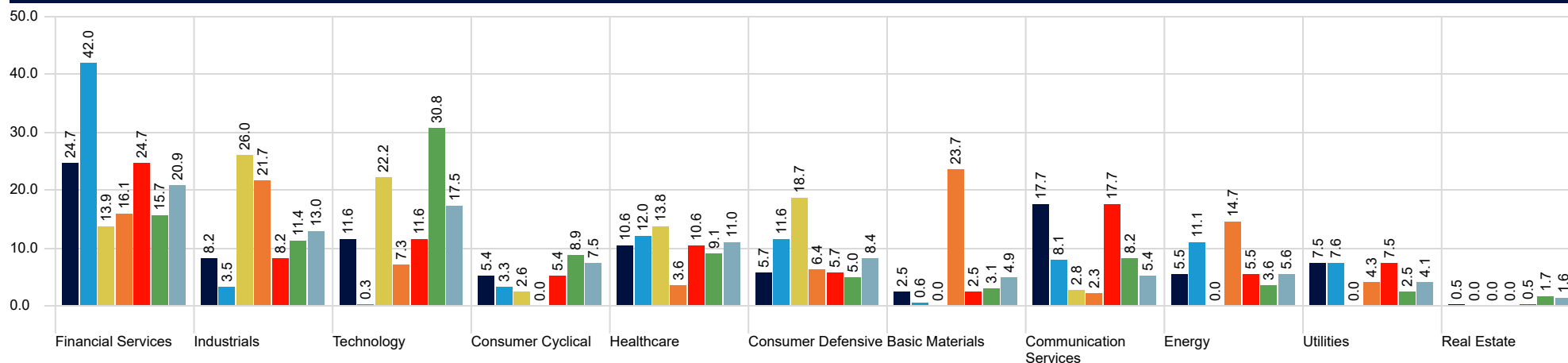

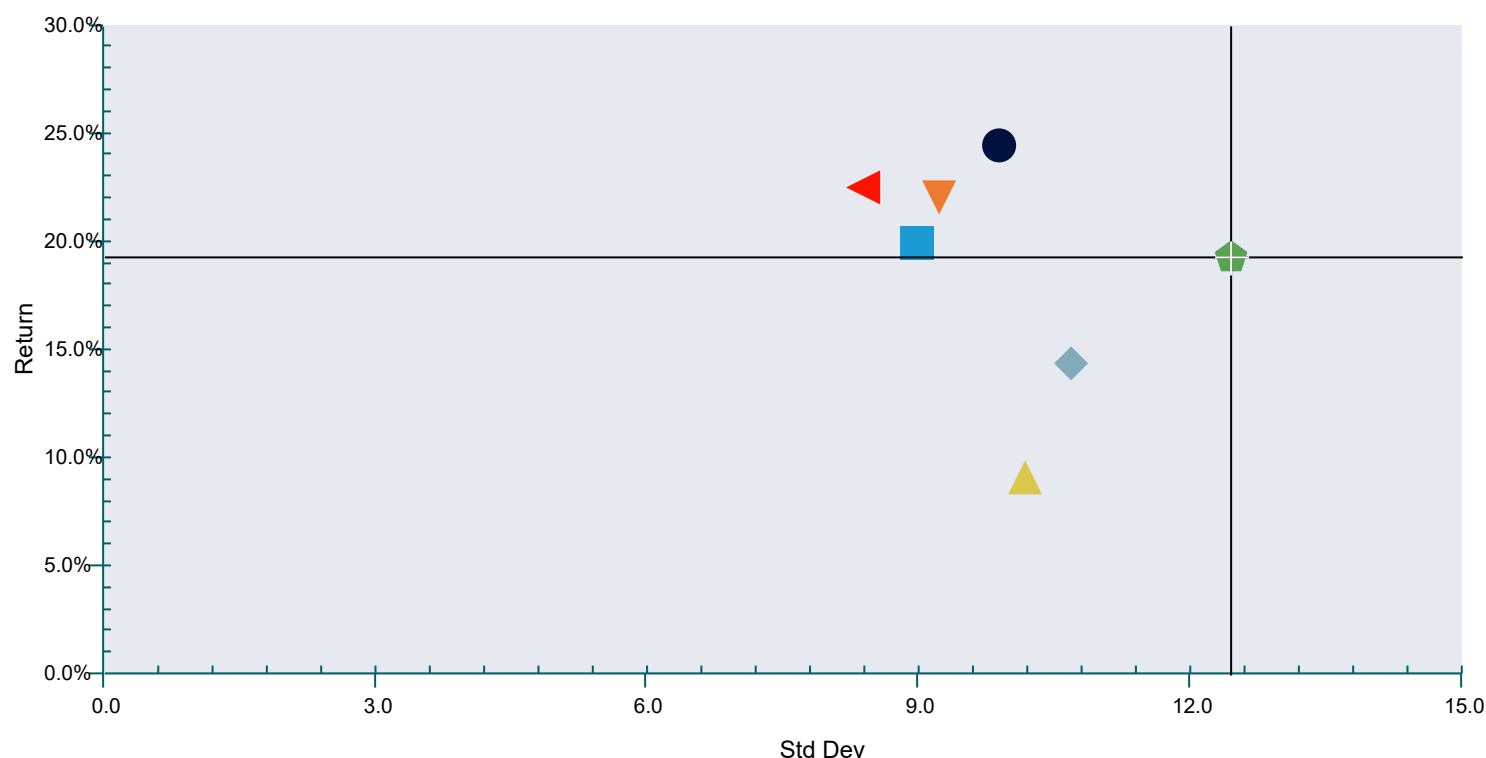

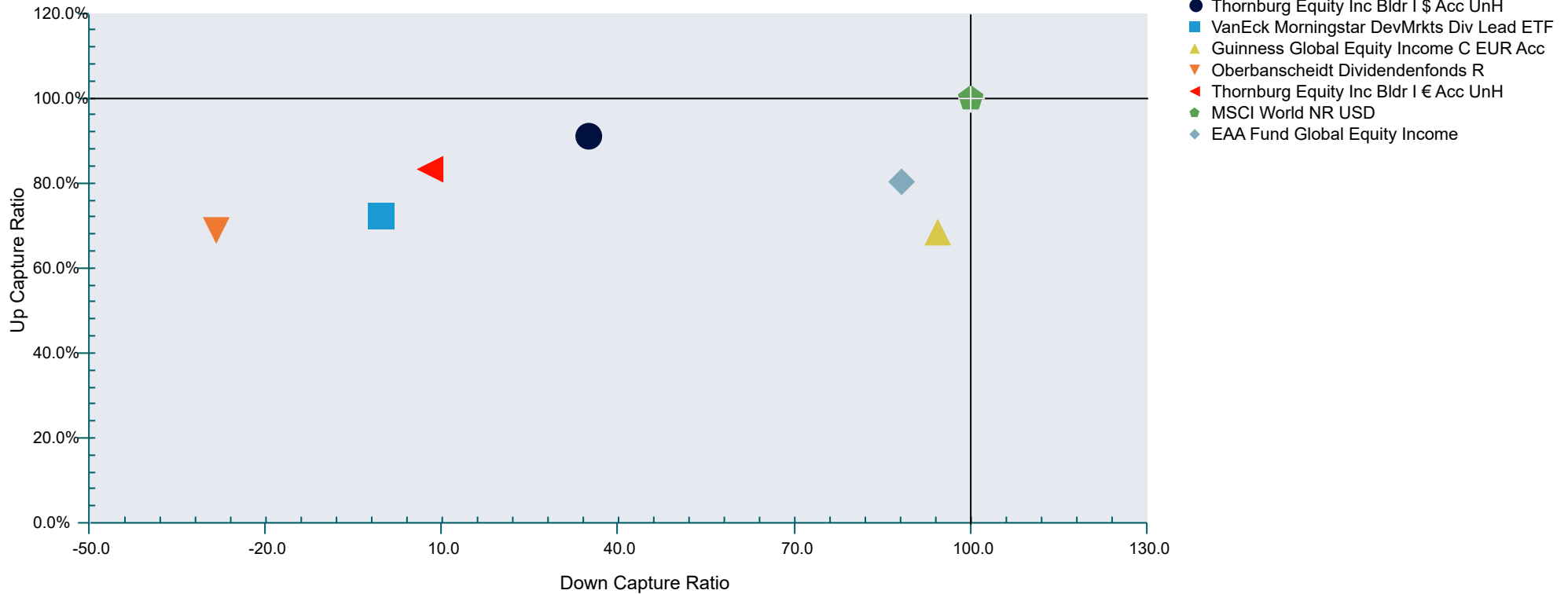

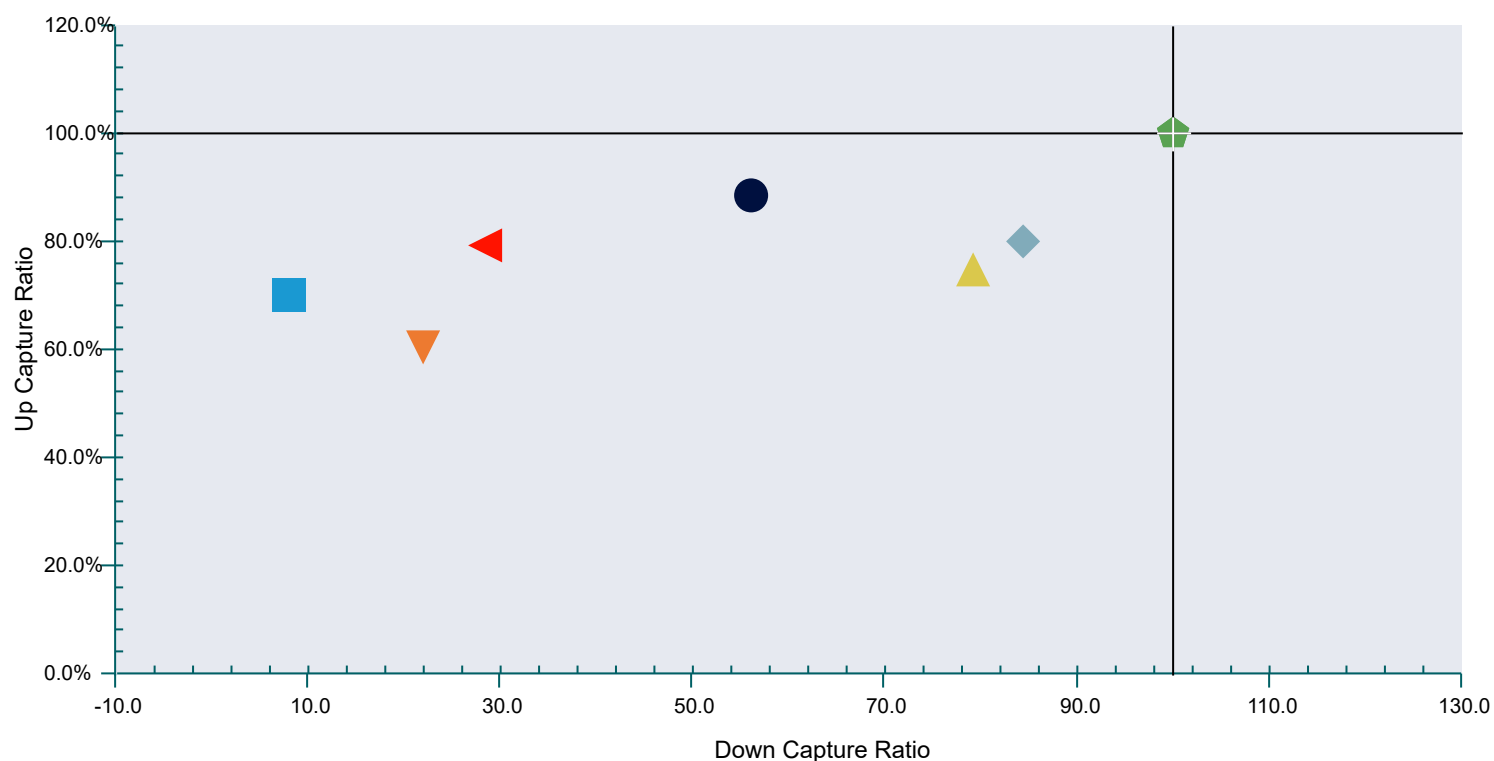

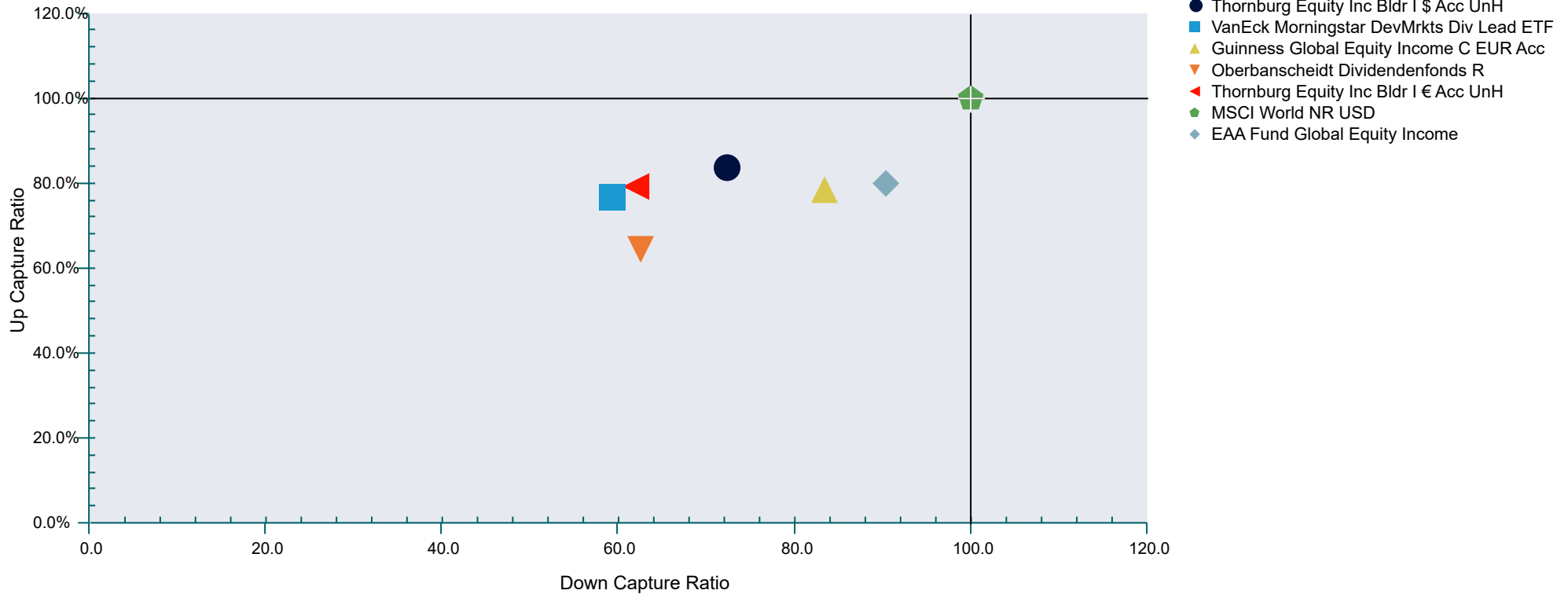

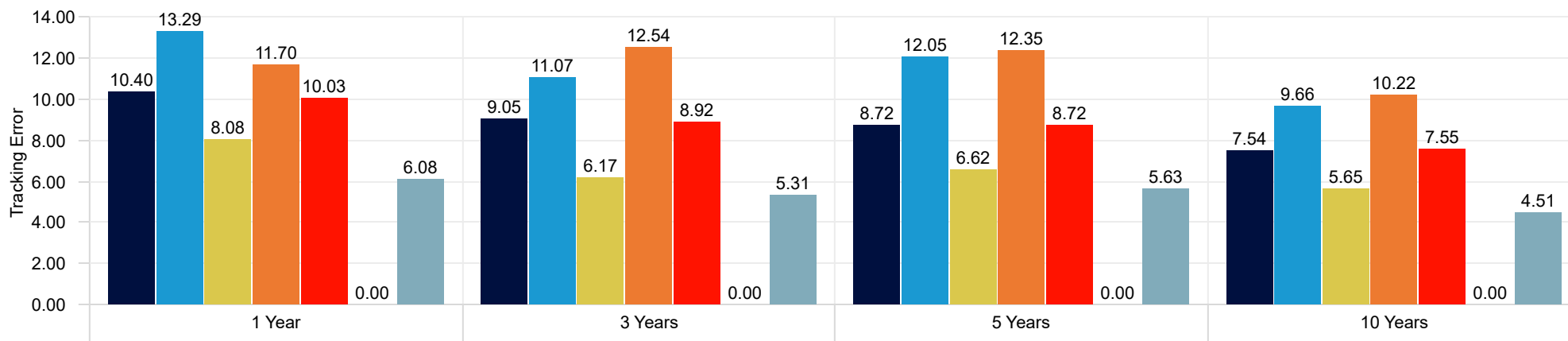
